**ORDER**

NOW on this 7<sup>th</sup> day of March, 2003, the application of Conservator, Tom Moran, for instructions from the Court regarding the handling of certain viatical policies subject to the Order Appointing Conservator and Transferring Assets dated February 6, 2002, came on for consideration before the undersigned judge. The Court, having reviewed the application and no objection being filed by the parties, finds as follows:

1. The Conservator does not have sufficient assets to continue to fund premium shortfalls on the policies;
2. The policies which have ABC investors named as irrevocable beneficiaries cannot be included in the sale of Conservatorship assets without the express written consent of all irrevocable beneficiaries on the policy;
3. The ABC investors who are named as irrevocable beneficiaries on policies should be given notice and the option of assigning their policies to the Conservator, for the purpose of having them included in the sale of Conservatorship Assets, or have the policies abandoned by the Conservatorship; and,
4. The Conservator's proposed plan for handling of policies with irrevocable

beneficiaries should be approved for good cause shown.


IT IS THEREFORE ORDERED ADJUDGED AND DECREED by the Court that the Conservator's proposed plan for handling of policies with irrevocable beneficiaries is approved.

IT IS FURTHER ORDERED ADJUDGED AND DECREED by the Court that the Conservator shall send notice to those ABC investors named as irrevocable beneficiaries, on policies under the control of the Conservatorship, of their option to assign their policies to the Conservator for the purpose of having the policy included in the sale of Conservatorship assets approved by the Court, or have the policies abandoned by the Conservator.


