ORDER LIFTING ASSET FREEZE

On this 22nd day of July, 2009, this matter came before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma. On December 27, 2007, a *Temporary Restraining Order, Order Freezing Assets and Order for Accounting* (the "*Temporary Restraining Order*") was entered by the Court. The *Temporary Restraining Order*, in part, froze the assets of Defendants including any funds located in any bank, depository institution, brokerage firm or other financial institution account.

Following the issuance of the *Temporary Restraining Order* and upon the motion of Plaintiff, a *Temporary Injunction* was issued by the Court on January 9, 2008. The *Temporary Injunction*, in part, ordered that the assets of Defendants remain frozen.

On March 7, 2008, a *Final Order, Judgment and Permanent Injunction* was issued by the Court forever enjoining and restraining Defendants from offering or selling

any security, as defined under the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003).

Based upon the pleadings, the evidence and the agreement of all parties, the Court finds that the asset freeze ordered by the Court in the *Temporary Restraining Order* and the *Temporary Injunction* should be lifted.

IT IS HEREBY ORDERED that the asset freeze ordered by the Court in the *Temporary Restraining Order* and the *Temporary Injunction* be, and hereby is lifted.


IT IS SO ORDERED.
