**APPLICATION TO ESTABLISH PROCEDURE TO
NOTIFY INVESTORS TO MAKE CLAIMS**

Comes now the Plaintiff and requests that the Court enter an order establishing a procedure to notify those persons (Investors), who invested money with Defendants, that they are required to file a proof of claim setting forth the nature and amount of their investments. In support of this Application, Plaintiff would show the Court as follows:

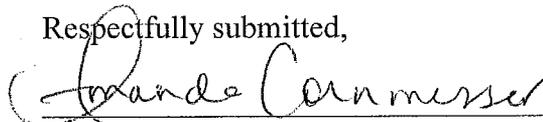
1. On June 28, 2007, Plaintiff filed a *Petition for Permanent Injunction and Other Equitable Relief* (Petition) against Defendants American Liberty Insurance & Financial Services, LightHouse Marketing Incorporated and Travis Ray Winnett (collectively "Defendants"). On June 29, 2006, this Court issued a *Temporary Restraining Order, Order Freezing Assets and Order for Accounting* against Defendants. On August 30, 2007, this Court issued a *Permanent Injunction* against Defendants.

2. The *Temporary Restraining Order* and *Permanent Injunction* included a freeze of the assets of Defendants. The Defendants' *Stipulation and Consent Order* filed on August 30, 2007, included an agreement to return all funds to Investors.

3. In order to determine the amount of money invested by and to be returned to the Investors, Plaintiff has prepared a notice and claim form to mail by regular mail to all Investors known to Plaintiff. *See Exhibit A.*

WHEREFORE, Plaintiff respectfully requests that this Court enter an order establishing a procedure, as set forth herein, to notify Investors to make claims and for such other and further relief as this Court deems just and equitable.

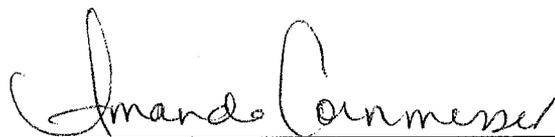

NOTICE AND DEADLINE TO FILE PROOF OF CLAIM

TO ALL INVESTORS HAVING CLAIMS AGAINST AMERICAN LIBERTY INSURANCE & FINANCIAL SERVICES, LIGHTHOUSE MARKETING INCORPORATED AND/OR TRAVIS RAY WINNETT. PLEASE REVIEW THIS NOTICE CAREFULLY AS YOUR RIGHTS MAY BE AFFECTED.

The Oklahoma Department of Securities (“Department”) filed a civil action on June 28, 2007, in Oklahoma County District Court alleging that Defendants engaged, directly and/or indirectly, in the offer and sale of insurance premium funding plans through which participants were promised returns of 8% per year for five years or 10% per year for six years (Premium Funding Plans). As a result of the civil action, a *Temporary Restraining Order, Order Freezing Assets and Order for Accounting* was entered against Travis Winnett, American Liberty Financial Services, and Lighthouse Marketing Incorporated (collectively, the “Defendants”).

At the Department’s request, the Honorable Patricia Parrish, Oklahoma County District Judge, entered an order on August 20, 2007, permanently enjoining the Defendants from offering and/or selling any securities in and/or from this state for a period of five (5) years, and ordering the return of all funds to participants in the Premium Funding Plans in such amounts and on such dates as subsequently determined by the Court (Repayment Schedule). The Court also ordered that the assets of Defendants remain frozen pending determination of the Repayment Schedule.

The Repayment Schedule will be based on a claims process to verify the identity of all participants and the total amount of their investments. Records indicate that you may have a

claim against Defendants. Enclosed is a proof of claim form for your completion. You will also need to document any payment(s) made to the Defendants, and any payment(s) received from the Defendants. Be sure to keep a copy of the claim for your records.

The deadline for submitting your claim is December 14, 2007. IF YOU DO NOT TIMELY SUBMIT A CLAIM WITH SUPPORTING DOCUMENTATION, YOU WILL NOT RECEIVE ANY DISTRIBUTION IN THIS MATTER. If you have any questions, please note those on the returned form. You may access information about the case at www.securities.ok.gov. Select "Enforcement Division," "Actions," and type "Winnett."
