JUDGMENT AND SENTENCE

This case came on for trial before the Court, the Honorable Patricia Parrish, District Judge, presiding, on December 11, 2009. Present for the Plaintiff, Oklahoma Department of Securities, *ex rel.* Irving L. Faught, Administrator, was its counsel, Amanda Cornmesser. Defendant, Travis Winnett, did not appear.

The Court, having received evidence, finds as follows:

1. that Defendant failed to make the One Thousand Dollar (\$1,000.00) payment due on May 1, 2009, and the One Thousand Dollar (\$1,000.00) payment due on June 1, 2009, to RCB in violation of the *Order Revising Terms of the Order of Repayment (Revised Order)*;
2. that Defendant's failures to make the May and June payments above constitute violations of this Court's *Revised Order* and is an instance of indirect contempt of Court;
3. that Defendant knowingly, willfully and contemptuously disobeyed and violated this Court's lawfully issued *Revised Order*.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED by the Court that the Defendant, Travis Winnett, is guilty of indirect criminal contempt of court for disobedience of the *Revised Order* entered by the Oklahoma County District Court, and is sentenced to six (6) months confinement in the Oklahoma County jail under the custody and control of the Oklahoma County Sheriff and payment of a \$500.00 fine on or before 6/30/10.
