**AGREED ORDER AUTHORIZING CONDITIONAL
INTERVENTION BY CRAIG ROARK AND CHAD ROARK**

This matter came on for hearing before this Court on November 24, 2009, to allow conditional intervention by Craig Roark and Chad Roark as a matter of right in the above-styled action. The Plaintiff contends that an unconditional intervention would undermine the efficient administration of the receivership and divert resources and the Receiver's efforts from activities intended to benefit the entire receivership. However, Plaintiff agrees to this conditional intervention by Craig Roark and Chad Roark due to their special status as the children of Bryan Roark and the title holders of certain receivership assets. The Court finds that good cause exists for authorizing such intervention on the terms set forth herein.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Craig Roark and Chad Roark will be allowed to intervene in this matter but only with respect to any issues relating to any real property which Craig Roark and/or Chad Roark hold title

and/or are the owner of record, and any cattle that may have been purchased by them, or for their benefit, with Investor Funds.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Craig Roark and Chad Roark as conditional intervenors will not be permitted to conduct discovery activities in this matter without seeking leave of court prior to taking such actions.






