**AGREED ORDER REQUIRING

NOW on this 3rd day of ^{December} ~~November~~, 2009, the Application of Receiver for Order Requiring Landmark Bank to Transfer or Turn Over Funds filed November 12, 2009 comes before the Court for consideration. Plaintiff is represented by its counsel of record, Jennifer Shaw and Amanda Cornmesser. The Receiver is represented by his counsel of record, Bradley E. Davenport. The Intervenors, Christiana Roark, Chad Roark and Craig Roark, are represented by their counsel of record, Clell I. Cunningham, III.

The Court, being fully advised in the premises and of the parties' agreement on the Receiver's Application finds that the Receiver's Application for Order Requiring Landmark Bank to Transfer or Turn Over Funds should be, and is hereby, granted.

IT IS THEREFORE ORDERED ADJUDGED AND DECREED that Landmark Bank, N.A., and specifically its Ada, Oklahoma branch, shall turn over to the Receiver, Douglas L. Jackson, all funds in the three checking accounts identified in the Application and which are in the name of Bryan David Roark or on which he was an authorized signer totaling \$423,405.73 within five (5) business days of this Order being entered.


