**ORDER ALLOWING WITHDRAWAL OF CLELL I. CUNNINGHAM III AS COUNSEL

IT IS FURTHER ORDERED that upon execution of this order, and until such time as Defendants, Global West Funding, Ltd, Global West Financial LLC, Sure Lock Financial, LLC, Sure Lock Loans, LLC, The Wave-Goldmade, Ltd., and Brian McKye exercise one of these options, service of all documents filed in this cause may be accomplished by United States Mail to the address above in accordance with 12 Okla.Stat. § 2005(B).
