**AGREED ORDER ALLOWING
RECEIVER ACCESS TO PROTECTED MATERIALS**

On May 15, 2009, this Court issued an Agreed Protective Order relating to an accounting provided by Storybook Properties, LLC and Storybook Investments WA, LLC to Plaintiff (Agreed Order). On June 9, 2009, this Court issued a Second Agreed Protective Order relating to all documents produced by Storybook Properties, LLC, Storybook Investments WA, LLC, and Matthew G. Story ("Storybook Defendants") during discovery or pre-trial proceedings between Storybook Defendants and Plaintiff (Second Agreed Order).

A receiver was appointed by this Court on October 7, 2009. Plaintiff and Storybook Defendants seek to modify the Agreed Order and Second Agreed Order to allow the court appointed receiver access to all documents produced by the Storybook Defendants under the protective orders.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the receiver shall have access to all documents provided by the Storybook Defendants to Plaintiff subject to the Agreed Order and the Second Agreed Order.






