**ORDER SUSPENDING BENCH WARRANT
& ALLOWING PAYMENT PLAN**

This matter came on for hearing on January 20, 2012, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, on the motion of Robert E. Tucker, a Defendant in the above numbered and styled case, to reconsider authorization of a bench warrant and allow a payment plan.

On considering the pleadings and other papers on file with the Court, evidence received, and the arguments of counsel considered, the Court finds and concludes that the motion should be granted.

IT IS THEREFORE ORDERED the six-month sentence imposed by the Court against the Defendants on August 31, 2011, for contempt be suspended. The Defendants shall pay the remaining balance of the March 30, 2011, Court-imposed civil penalty, \$6,500.00, in monthly installments of \$750.00 beginning on February 15, 2012, until April 15, 2012. The Defendants shall then make a final payment of the remaining balance, \$4,250.00, no later than May 15, 2012. The Defendants shall make all payments promptly and fully. The Plaintiff may, upon the Defendants' failure to make any payment promptly and/or fully, motion this Court to reinstate the six-month sentence for contempt.




