AGREED ORDER AUTHORIZING CONDITIONAL  
INTERVENTION BY WAYNE DOYLE

This matter comes on for consideration pursuant to the *Motion of Wayne Doyle for Leave to Intervene as Party Defendant*, filed on January 15, 2015. Plaintiff contends that an unconditional intervention would undermine the efficient administration of the receivership, divert resources, and interfere with the Receiver's activities intended to benefit the entire receivership estate. However, the parties agree to this conditional intervention by Wayne Doyle due to his status as a previous owner of the hotel, his claimed mortgage filed against the Bricktown Hotel, and the funds interpled within this case under the *Agreement on Instruction for Closing* dated December 22, 2014. The Court finds that good cause exists for authorizing conditional intervention on the terms set forth herein.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Wayne Doyle will be allowed to intervene as a non-party in this matter but only with respect to the interpled proceeds in the amount of \$187,858.90 from the sale of the Bricktown Hotel.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Wayne Doyle shall seek any other funds from the receivership estate only through the claim process established by this Court on January 22, 2015.

IT IS FURTHER ORDER, ADJUDGED AND DECREED that this Order shall not prejudice any other rights, claims or assertions Wayne Doyle may claim to additional proceeds obtained by the Receiver arising from the sale of the Bricktown Hotel, but any such claim shall be asserted in the claim process established by this Court on January 22, 2015.




