ORDER

On February 6, 2015, Quail Creek Bank’s “Motion for Order Instructing Agent to Disburse Escrow Funds to Quail Creek Bank” and all objections thereto, and Bricktown Capital, LLC’s separate “Motion for Order Instructing Escrow Agent to Disburse Escrow Funds, Instructing Receiver to Pay Hotel Vendors”, and all objections thereto came on for hearing before the undersigned Judge of the District Court of Oklahoma County.

On February 18, 2015,(the “February 18 Order”) this Court entered an Order disbursing the sum of \$6,064.20 to Quail Creek Bank and disbursing the remaining balance thereof to the Reciver appointed therein.

On February 27, 2015, Defendant Bricktown Capital, LLC filed it’s motion to strike the February 18 Order on the grounds that order inaccurately stated that Defendant withdrew it’s objection to the disbursement of funds to Quail Creek Bank.

This Court, having considered the “Motion for Order Instructing Agent to Disburse Escrow Funds to Quail Creek Bank” and Defendant Bricktown Capital LLC's “Motion to Strike Order Disbursing Escrow Funds to Quail Creek Bank and to Substitute Corrected Order”, finds and orders

as follows:

THE COURT FINDS that the February 18, 2015 Order is stricken and rendered moot on the grounds that order inaccurately stated that Defendant withdrew it's objection to the disbursement of funds to Quail Creek Bank.

IT IS THEREFORE ORDERED that the February 18, 2015 Order is stricken and rendered moot.

IT IS FURTHER ORDERED that with respect to the \$17,797.94 currently held in escrow by Stewart Abstract & Title of Oklahoma ("Stewart Abstract"), that Stewart Abstract shall immediately disburse to Quail Creek Bank the sum of \$6,064.20, and shall immediately disburse the remaining balance thereof to the Receiver appointed therein.

IT IS FURTHER ORDERED that Plaintiff Oklahoma Department of Securities *ex rel.* Irving L. Faught, Administrator's "Motion for Reimbursement of Fees" as contained within its Response to Quail Creek Bank's aforesaid Motion is hereby denied.




