AGREED ORDER TO CONTINUE HEARING

On February 1, 2017, the Oklahoma Department of Securities (“Department”), *ex rel.* Irving L. Faught, Administrator, filed a verified *Petition for Permanent Injunction and Other Relief* against the named Defendants pursuant to the Oklahoma Business Opportunity Sales Act (the “Business Opportunity Act”), Okla. Stat. tit. 71, §§ 801 through 829 (2011), and/or the Oklahoma Uniform Securities Act of 2004 (the “Securities Act”), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011 and Supp. 2016).

On February 1, 2017, the Department filed the *Application for Temporary Restraining Order, Order Freezing Assets, and Temporary Injunction*.

On February 1, 2017, this Court entered the *Temporary Restraining Order and Order Freezing Assets (Temporary Order)*, and scheduled a hearing at 1:30 p.m. on February 17, 2017, at which time the Defendants could seek the dissolution of the Temporary Order and the Department could seek a temporary injunction and other equitable relief (TRO Hearing).

Defendants have requested additional time to prepare for the TRO Hearing and the parties have agreed to extend the hearing date to March 24, 2017 at 1:30 p.m.

IT IS HEREBY ORDERED that the TRO Hearing be continued to March 24, 2017 at 1:30 p. m.

IT IS FURTHER ORDERED that all other provisions of the Temporary Order shall remain in full force and effect.


