OF OCTOBER 1, 2015 THROUGH JUNE 30, 2016**


NOW on this 26th day of August, 2016, the application of Conservator, Tom Moran, for entry of an Order approving the interim application for Conservator's fees and expenses for the period of October 1, 2015 through June 30, 2016, came on for consideration before the undersigned Judge. The Court having reviewed the application, being advised that Plaintiff has no objection to the granting of this application, and no objection being filed by Defendants, finds that the Conservator's Application should be granted for good cause shown. The Court further finds that the Conservator's Report for the period of October 1, 2015 through June 30, 2016, should be approved.

IT IS THEREFORE ORDERED ADJUDGED AND DECREED that the interim application of Conservator, Tom Moran, for order approving Conservator's fees in the amount of \$1,871.25 for the month of October 2015, \$1,280.50 for the month of November 2015, \$6,704.00 for the month of December 2015, \$6,960.00 for the month of January 2016, \$4,538.00 for the month of February 2016, \$3,568.00 for the month of March 2016, \$3,935.75 for the month of

April 2016, \$4,143.25 for the month of May 2016, and \$7,596.03 for the month of June 2016, is hereby granted.

IT IS FURTHER ORDERED ADJUDGED AND DECREED that the Conservator's Report the period of October 1, 2015 through June 30, 2016, is hereby approved.


