

3. That the Administrator has received service of process on behalf of Respondents pursuant to Section 1-611 of the Act.





ORDER TO CEASE AND DESIST
AND
NOTICE OF OPPORTUNITY FOR HEARING

Order to Cease and Desist

Pursuant to Section 1-602 of the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003), an investigation was conducted by the Enforcement Division of the Oklahoma Department of Securities (Department) into the activities of Premier Tickets, Inc. and Melvin Anthony McGhee (collectively, Respondents) in connection with the offer and/or sale of securities in and/or from the state of Oklahoma.

Based thereon, the following Findings of Fact, Authorities, and Conclusions of Law are submitted to the Administrator of the Department (Administrator), or his designee, in support of the issuance of an order to cease and desist.

Findings of Fact

1. At all times relevant hereto, Premier Tickets, Inc. (Premier Tickets) was purported to be a Kentucky company. Beginning in approximately 2008, Premier Tickets issued, offered and/or sold investment interests ("Interests") to at least one Oklahoma investor ("Investor").
2. At all times material hereto, Melvin Anthony McGhee (McGhee), an individual, was a resident of the state of Oklahoma. McGhee is not, and has never been, registered in any capacity under the Act. At all times material hereto, McGhee offered and/or sold the Interests on behalf of Premier Tickets.
3. In approximately January of 2008, McGhee contacted J. Frederick (Frederick), an Oklahoma resident, to offer an Interest in Premier Tickets.

4. McGhee represented that an investment with Premier Tickets would allow concerts to come to the Oklahoma City area and Frederick would receive a percentage of ticket sales as a return on his investment.

5. During January and February of 2008, Frederick invested Forty Thousand Dollars (\$40,000) in cash with Premier Tickets.

6. McGhee has failed to respond to Frederick and no concerts have been brought to Oklahoma City.

7. Frederick has not received any return on his investment with Premier Tickets.

8. McGhee is not registered in any capacity under the Act.

9. The Interests offered and sold by Respondents in the state of Oklahoma were not registered pursuant to Section 1-301 of the Act. In addition, there has not been a filing made with the Administrator to claim an exemption from registration.

To the extent any of these Findings of Fact are more properly characterized as Conclusions of Law, they should be so considered.

Authorities

1. Section 1-102 of the Act provides in pertinent part:

32. "Security" means a note...evidence of indebtedness...[or] investment contract[.]

2. Section 1-301 of the Act provides:

It is unlawful for a person to offer or sell a security in this state unless:

- (1) The security is a federal covered security;
- (2) The security, transaction, or offer is exempted from registration under Sections 6 through 8 of this act [Sections 1-201 through 1-203 of this title]; or
- (3) The security is registered under the act.

3. Section 1-402 of the Act provides:

A. It is unlawful for an individual to transact business in this state as an agent unless the individual is registered under this act as an agent or is exempt from registration as an agent under subsection B of this section.

* * *

D. It is unlawful for a broker-dealer, or an issuer engaged in offering, selling, or purchasing securities in this state, to employ or associate with an agent who transacts business in this state on behalf of broker-dealers or issuers unless the agent is registered under subsection A of this section or exempt from registration under subsection B of this section.

4. Section 1-604 of the Act provides in part:

A. If the Administrator determines that a person has engaged, is engaging, or is about to engage in an act, practice, or course of business constituting a violation of this act or a rule adopted or order issued under this act or constituting a dishonest or unethical practice or that a person has materially aided, is materially aiding, or is about to materially aid an act, practice, or course of business constituting a violation of this act or a rule adopted or order issued under this act or constituting a dishonest or unethical practice, the Administrator may:

1. Issue an order directing the person to cease and desist from engaging in the act, practice, or course of business or to take other action necessary or appropriate to comply with this act[.]

* * *

B. An order under subsection A of this section is effective on the date of issuance. Upon issuance of the order, the Administrator shall promptly serve each person subject to the order with a copy of the order and a notice that the order has been entered. The order must include a statement whether the Administrator will seek a civil penalty or costs of the investigation, a statement of the reasons for the order, and notice that, within fifteen (15) days after receipt of a request in a record from the person, the matter will be scheduled for a hearing and the hearing shall be commenced within fifteen (15) days of the matter being set for hearing. If a person subject to the order does not request a hearing and none is ordered by the Administrator, within thirty (30) days after the date of service of the order, the order, that may include a civil penalty or costs of the investigation if a civil penalty or costs were sought in the statement accompanying the order, becomes final as to that person by operation of

law. If a hearing is requested or ordered, the Administrator, after notice of and opportunity for hearing to each person subject to the order, may modify or vacate the order or extend it until final determination.

Conclusions of Law

1. The Interests are securities as defined by Section 1-102 of the Act.
2. McGhee offered and sold an unregistered security in the state of Oklahoma, in violation of Section 1-301 of the Act.
3. McGhee transacted business as an agent in this state without the benefit of registration under the Act, in violation of Section 1-402 of the Act.
4. Premier Tickets employed or associated with at least one unregistered agent to transact business in this state on its behalf, in violation of Section 1-402 of the Act.
5. The Administrator has the authority to order Respondents to cease and desist from engaging in an act, practice, or course of business constituting a violation of the Act.
6. It is in the public interest to order Respondents to cease and desist from violating the Act and to impose a civil penalty.


To the extent any of these Conclusions of Law are more properly characterized as Findings of Fact, they should be so considered.

NOW THEREFORE, it is hereby ordered that Respondents cease and desist from engaging in any act, practice, or course of business constituting a violation of the Act or a rule adopted or order issued under the Act to include, offering and selling unregistered securities and/or transacting business as an agent without benefit of registration.

Notice of Opportunity for Hearing


Pursuant to Section 1-604 of the Act, the Administrator hereby gives notice to Respondents of their right to request a hearing. The request for hearing must be received by the Administrator within thirty (30) days after service of the Order to Cease and Desist (Order). The request for hearing must be in writing and Respondents shall specifically admit or deny each allegation that is contained in the Order.

Within fifteen (15) days after receipt of a request for hearing from Respondents, this matter will be scheduled for hearing. The hearing shall commence within fifteen (15) days of the matter being set for hearing. Notice of the date, time and location of the hearing shall be given to Respondents. If a hearing is requested, the Administrator, after notice of and opportunity for hearing, may modify or vacate the Order or extend it until final determination.

If Respondents do not request a hearing within thirty (30) days after the date of service of the Order and none is ordered by the Administrator, the Order becomes final as to Respondents by operation of law.
