CITATION OF CRIMINAL CONTEMPT
AGAINST EMZIE HULETTY

To: **EMZIE HULETTY**

Plaintiff has filed an application that claims you failed to comply with the Temporary Restraining Order, Order Appointing Receiver, Order Freezing Assets and Order For Accounting ("Temporary Order") made and entered on the 17th day of September, 2003, wherein this Court enjoined you, your agents, employees, attorneys, and those persons in active concert or participation with you, from: offering or selling securities in and/or from this state; transacting business in this state as a broker-dealer or agent unless appropriately registered under the Act;

directly or indirectly making any untrue statements of material fact or omitting to state material facts necessary in order to make statements made, in light of the circumstances under which they are made, not misleading, in connection with the offer, sale, and/or purchase of securities in and/or from this state; directly or indirectly, engaging in any act, practice, or course of business which operates or would operate as a fraud or deceit upon any person; and unlawfully distributing sales literature in and/or from this state.

Further, Plaintiff's application claims you failed to comply with the Temporary Order, wherein this Court ordered you to transfer or deliver possession, custody, and control to the Receiver or to the Oklahoma County Sheriff of all assets of the Receivership Defendants; all documents of the Receivership Defendants including, but not limited to books, records, tapes, discs, accounting data, checks, correspondence, forms, advertisements, brochures, manuals, electronically stored data, bank records, customer lists, customer files, telephone records, ledgers, payroll records, including information stored in computer maintained form; all assets belonging to members of the public held by Defendants; and all keys and codes necessary to gain or to secure access to any assets or documents of the Receivership Defendants including, but not limited to access to their business premises, means of communication, accounts, computer systems, or other property, wherever located.

Finally, Plaintiff's application claims you failed to comply with the Order Granting Motion to Compel Defendants to Produce Property made and entered on the 11th day of March, 2004, wherein this Court ordered you to "immediately produce and surrender" a certain 2001 Dodge Durango to Receiver Win Holbrook.

YOU ARE THEREFORE COMMANDED TO APPEAR before this Court on the 2nd
day of April, 2004, at 10:00 A.m. and show cause why you should not be
punished for contempt of court.
