**FINAL ORDER TO CEASE AND DESIST**

The Administrator of the Oklahoma Department of Securities ("Department") issues this Final Order to Cease and Desist against Lynn Larry Strickland, Jr. (aka, "Skipper Strickland") ("Respondent") pursuant to Section 1-604 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011).

On July 8, 2014, and pursuant to Section 1-604 of the Act, the Administrator of the Department ("Administrator") issued the attached Order to Cease and Desist ("C&D") that is incorporated herein by reference.

On July 8, 2014, the Administrator, in order to notify the Respondent of his obligation to file an answer and his right to request a hearing to show why a final order based on the C&D should not be issued: filed a Notice of Opportunity for Hearing ("Notice") pursuant to Section 1-604 of the Act; filed a Notice of Service on the Administrator and Affidavit of Compliance ("Affidavit") pursuant to Section 1-611 of the Act; and sent the C&D, Notice and Affidavit (collectively, the "Filings") by certified mail, return receipt requested, delivery restricted, to the Respondent at his last known addresses.

On July 10, 2014, Respondent signed the return receipt for the Filings mailed to one of his last known addresses.

The deadline for Respondent to file an answer to the C&D and to request a hearing to show why a final order based on the C&D should not be issued has passed. Respondent has not filed an answer to the C&D or requested a hearing.

**ORDER**

**IT IS HEREBY ORDERED** that, pursuant to Section 1-604 of the Act, the Order to Cease and Desist issued on July 8, 2014, is final by operation of law.
