**FINAL ORDER TO CEASE AND DESIST**

The Administrator of the Oklahoma Department of Securities ("Department") issues this *Final Order to Cease and Desist* ("Final Order") pursuant to Section 1-604 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011).

On December 27, 2013, the Administrator of the Department ("Administrator"), pursuant to Section 1-604 of the Act, ordered the Respondents to immediately cease and desist from offering and selling unregistered securities, making untrue statements and omissions of material fact in connection with the offer and sale of securities, and transacting business as a broker-dealer, agent, investment adviser, and/or investment adviser representative, in and/or from Oklahoma in violation of the Act ("C&D").

On December 27, 2013, pursuant to Section 1-611 of the Act, service on Respondents was made by serving the Administrator. On December 27, 2013, the Administrator, in order to notify the Respondents of their obligation to file an answer and their right to request a hearing to show why a final order based on the C&D should not be issued, filed a *Notice of Opportunity for Hearing* ("Notice") pursuant to Section 1-604 of the Act; filed a *Notice of Service on the Administrator and Affidavit of Compliance* ("Affidavit") pursuant to Section 1-611 of the Act; and sent the C&D, Notice and Affidavit (collectively, the "Filings") via certified mail, return receipt requested, delivery restricted, to the Respondents.

To date, Respondents have not filed an answer and have not requested a hearing to show why a final order based on the C&D should not be issued.

**ORDER**

**IT IS HEREBY ORDERED** that, pursuant to Section 1-604 of the Act, the C&D issued on December 27, 2013, is final by operation of law.


