FINAL ORDER TO CEASE AND DESIST

Pursuant to the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011), an investigation was conducted by the Oklahoma Department of Securities (Department) into the activities of Allied Management Services, American Advantage Title, Alan Cooper, Dennis Newman, Brad Johnson, Gina Gersh and Mark Roberts (collectively, "Respondents"), in connection with the offer, sale and/or purchase of securities in and/or from Oklahoma.

On March 21, 2012, the Administrator of the Department (Administrator) issued an *Order to Cease and Desist* and *Notice of Opportunity for Hearing (Order and Notice)* against Respondents. Pursuant to Section 1-611 of the Act, service of the Order and Notice upon Respondents was effected by service upon the Administrator on March 21, 2012. Pursuant to Section 1-604 of the Act, the *Order and Notice* were mailed to Respondents at their last known addresses, by certified mail, return receipt requested, and delivery restricted, on March 21, 2012. The mailings were all returned to the Department marked as follows:

Allied Management Services: "Return To Sender, Allied Management Services, Moved Left No Address, Unable To Forward, Return To Sender"
American Advantage Title, Alan Cooper, Dennis Newman, Brad Johnson, Gina Gersh and Mark Roberts: "Return To Sender, Not Deliverable As Addressed, Unable To Forward"


No request for hearing has been received by the Administrator.


