**FINAL ORDER, JUDGMENT, AND PERMANENT INJUNCTION FOR
DEFENDANT NEHER MESSENGER FARMS, INC.**

This matter came on for hearing this 7th day of March, 2006,
before the undersigned Judge of the District Court in and for Oklahoma County, State of
Oklahoma, upon Plaintiff's Petition for Permanent Injunction and Other Equitable Relief
("Petition"), pursuant to Section 1-603 of the Oklahoma Uniform Securities Act of 2004 ("Act"),
Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003), and the Oklahoma Securities Act
("Predecessor Act"), Okla. Stat. tit 71, §§ 1-413, 501, 701-703 (2001 & Supp. 2003).

After a review of the pleadings and evidence, this Court finds:

1. At all times material hereto, Defendant NMF engaged in the issuance, offer and/or sale of securities in the nature of preferred stock in NMF ("NMF Stock") in and/or from the state of Oklahoma to investors ("Investors").
2. Shares of NMF Stock are securities as defined by Section 1-102 of the Act and Section 2 of the Predecessor Act.

3. The securities offered and sold by Defendant NMF are not, and have not been, registered under the Act or the Predecessor Act. The securities offered and sold by Defendant NMF are not exempt from registration pursuant to Section 1-201 of the Act or Section 401 of the Predecessor Act.

4. Defendant NMF employed unregistered agents in violation of Section 1-402 of the Act and Section 201 of the Predecessor Act.

5. Defendant NMF, in connection with the offer, sale or purchase of securities, directly and indirectly, made untrue statements of material fact and omitted to state material facts necessary in order to make the statements made, in light of the circumstances under which they were made, not misleading, in violation of Section 1-501 of the Act and Section 101 of the Predecessor Act.

6. Defendant NMF, in connection with the offer, sale, or purchase of securities, and through the use of untrue statements of material fact and the omissions of material facts, engaged in an act, practice, or course of business that has operated as a fraud or deceit upon Investors, in violation of Section 1-501 of the Act and Section 101 of the Predecessor Act.

7. Defendant NMF has executed the Stipulation and Consent to Final Order by Defendant Neher Messenger Farms, Inc. ("Stipulation and Consent") attached hereto as Exhibit "A" and made a part hereof. Plaintiff has no objection to the terms of the Stipulation and Consent and agrees to the entry of this Final Order, Judgment and Permanent Injunction for Defendant Neher Messenger Farms, Inc. ("Final Order").

8. There is a likelihood of future violations of the Act by Defendant NMF if it is not enjoined.

Therefore, based on the pleadings, evidence, and the execution of the Stipulation and Consent, the Court finds that Plaintiff is entitled to the relief prayed for and that this Final Order be issued by agreement of the parties, and, therefore:

IT IS HEREBY ORDERED that a permanent injunction be and is hereby entered, forever enjoining and restraining Defendant NMF from offering or selling securities in and/or from this state and from directing other natural persons, corporations, or other business entities acting on its behalf to offer or sell securities in and/or from this state.

IT IS FURTHER ORDERED that this Court will retain jurisdiction of this matter for the purpose of enforcement of this Final Order and the Stipulation and Consent.

IT IS SO ORDERED.

**STIPULATION AND CONSENT TO FINAL ORDER
BY DEFENDANT NEHER MESSENGER FARMS, INC.**

Defendant Neher Messenger Farms, Inc. ("Defendant NMF") stipulates to the following facts and consents to the follow undertakings:


Stipulations:

Defendant NMF hereby stipulates as follows:

1. The Oklahoma Department of Securities ("Plaintiff") is the proper party to bring this action seeking the relief requested in the Petition for Permanent Injunction and Other Equitable Relief ("Petition") filed in this matter.

2. Defendant NMF is subject to the jurisdiction of this Court by proper service of the Petition and its appearance in this matter.

3. Defendant NMF engaged in the issuance, offer, and/or sale of securities in the nature of stock ("NMF Stock") in and/or from Oklahoma to investors ("Investors"). Shares of NMF Stock are securities as defined by Section 1-102 of the Oklahoma Uniform Securities Act



of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003), and Section 2 of the Oklahoma Securities Act ("Predecessor Act"), Okla. Stat. tit. 71, §§ 1-413, 501, 701-703 (2001 & Supp. 2003).

4. Defendant NMF admits to the application of the Act and the Predecessor Act to the issuance, offer, and/or sale of securities in and/or from Oklahoma referenced in paragraph 3 above.

Undertakings:

Defendant NMF hereby undertakes as follows:

1. Defendant NMF consents to the entry of the Final Order, Judgment, and Permanent Injunction for Defendant Neher Messenger Farms, Inc. ("Final Order"), in the form attached as Exhibit "A" hereto and made a part of this Stipulation and Consent to Final Order by Defendant Neher Messenger Farms, Inc. ("Stipulation and Consent").

2. Defendant NMF states that this Stipulation and Consent is entered into voluntarily and that no threat or promise of immunity of any kind has been made by Plaintiff, the Oklahoma Securities Commission, the Administrator of the Oklahoma Department of Securities, or any employee of the Oklahoma Department of Securities, to coerce agreement with this Stipulation and Consent.

3. Defendant NMF waives any right to appeal from the Final Order.

4. Defendant NMF agrees that this Stipulation and Consent and all provisions hereof shall be incorporated by reference into the Final Order.

5. Defendant NMF agrees that it will immediately disassociate from doing business of any kind with Defendant Platt.

6. Defendant NMF understands that Plaintiff will take action as authorized by law for Defendant NMF's failure to comply with the terms of the Final Order and this Stipulation and Consent in any material respect or for any future violation of the Act.

7. Defendant NMF agrees to the presentation to the Court of this Stipulation and Consent, executed by Defendant NMF, and to the entry of the Final Order, in the form attached as Exhibit "A", without further notice.

8. Defendant NMF consents to the Court's retention of jurisdiction of this matter for all purposes including, but not limited to, enforcement of the Final Order and this Stipulation and Consent.
