**FINAL ORDER TO CEASE AND DESIST**

Pursuant to the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2009), an investigation was conducted by the Oklahoma Department of Securities (Department) into the activities of Humble Petroleum, Inc. (Humble), United Global Technologies, Inc. (United), Global Management Inc. (Global), and Richard M. Linz (Linz) (collectively, "Respondents"), in connection with the offer and/or sale of securities in and/or from the state of Oklahoma.

On June 30, 2011, the Administrator of the Department (Administrator) issued an *Order to Cease and Desist* and *Notice of Opportunity for Hearing (Order and Notice)* against Respondents. Pursuant to Section 1-611 of the Act, service of the Order and Notice upon Respondents was effected by service upon the Administrator on June 30, 2011. Pursuant to Section 1-604 of the Act, the *Order and Notice* were mailed to Respondents at their last known addresses, by certified mail, return receipt requested, and delivery restricted, on June 30, 2011. The Humble mailing was received and signed for by a David Kane, Humble Chairman and Chief Executive Officer. The return receipt was received by the Department on July 6, 2011. The United mailing was received and signed for by Linz. The return receipt was received by the Department on July 11, 2011. The Global mailing was received and signed for by Linz. The return receipt was received by the Department on July 7, 2011. Linz received and signed for his mailing. The return receipt was received by the Department on July 7, 2011.

No request for hearing has been received by the Administrator.

The Administrator, being fully advised in this matter, finds that the issuance of this Order is in the public interest and hereby adopts the Findings of Fact and Conclusions of Law set forth in the Order and Notice.

**THEREFORE**, pursuant to Section 1-604 of the Act, the cease and desist order issued by the Administrator against Respondents on June 30, 2011, is final by operation of law.


