



**RESPONDENT NORMAN FRAGER'S JOINDER IN GEARY RESPONDENTS'
MOTION TO STRIKE WITNESSES AND ALLEGATIONS, MOTION FOR
PROTECTIVE ORDER TO LIMIT SCOPE OF DEPOSITIONS, RESPONSE
AND OBJECTION TO BANK OF UNION'S MOTION TO QUASH, AND
ALTERNATIVE MOTION FOR EXPEDITED ENFORCEMENT OF
SUBPOENA**

Pursuant to Rule 660:2-9-3(c) of the Rules of the Oklahoma Department of Securities, Respondent, Norman Frager ("Frager") submits this joinder to the Respondents Geary Securities, Inc. (formerly known as Capital West Securities, Inc.), Keith D. Geary, and CEMP, LLC (the "Geary Respondents") Motions filed March 14, 2011 requesting that the Hearing Officer: (1) issue an Order striking witnesses and allegations relating to the Bank of Union and Timothy Headington; (2) issue an Order limiting the scope of all future depositions in this action (including, but not limited to, the depositions of Geary Respondents); (3) issue an Order denying the "Motion to Quash and For Protective Order" filed on behalf of the Bank of Union, John Shelley, Mike Braun, and Timothy Headington; and (4) alternatively, immediately apply to the applicable District Courts to enforce and obtain compliance with the subject subpoenas and pursue any and all applicable civil penalties, fees and contempt citations.


