ORDER SETTING HEARING

WHEREAS, on September 15, 2005, an Enforcement Division Recommendation was submitted to the Administrator of the Oklahoma Department of Securities (Department) in support of the issuance of an order to cease and desist against Issac Sheppard Funderburk (Funderburk) and Home Alert, Incorporated (Home Alert). The Recommendation contains proposed Findings of Fact, Authorities, and Conclusions of Law.

WHEREAS, on October 5, 2005, a copy of the Notice of Opportunity for Hearing (Notice) with the Recommendation attached was mailed to the last known addresses of Funderburk and Home Alert, in compliance with Section 814.B of the Oklahoma Business Opportunity Sales Act (Act), Okla. Stat. tit. 71, §§ 801-829 (2001).

WHEREAS, a written request for hearing on the Recommendation was received by the Department on November 1, 2005, on behalf of Funderburk and Home Alert.

WHEREAS, the Administrator finds that the request for hearing on the Recommendation was timely received.

IT IS HEREBY ORDERED that pursuant to 660:2-9-2 of the Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities, a hearing shall commence at 10:00 a.m. on January 10, 2005, in the offices of the Oklahoma Department of Securities, First National Center, Suite 860, 120 North Robinson, Oklahoma City, Oklahoma, to afford Funderburk and Home Alert the opportunity to present evidence and argument as to whether or not an order should be issued based on the Recommendation.


