SCHEDULING ORDER

On September 15, 2005, the Administrator (Administrator) of the Oklahoma Department of Securities (Department) issued a Notice of Opportunity for Hearing (Notice) in the above styled and numbered cause. Notice was served on Respondents on October 17, 2005. The Department received a written request for hearing on the attached Enforcement Division Recommendation (Recommendation) on November 1, 2005, on behalf of Respondents Issac Sheppard Funderburk (Funderburk) and Home Alert, Incorporated (Home Alert). In their answer, Respondents Funderburk and Home Alert failed to deny the Findings of Fact contained in paragraphs one (1) through ten (ten) of the Recommendation.

On December 8, 2005, counsel for the Department's Enforcement Division telephoned Respondent Funderburk and attempted to prepare an agreed scheduling order. The parties were unable to agree to a single scheduling order.

This Scheduling Order is issued pursuant to 660:2-9-3 of the Rules of the Oklahoma Securities Commission and the Administrator of the Oklahoma Department of Securities (Rules).

IT IS HEREBY ORDERED that:

1. The Findings of Fact contained in paragraphs one (1) through ten (10) of the Recommendation are deemed to be admitted. The Conclusions of Law contained in the Recommendation are at issue.

2. The original of all pleadings and exhibits and/or other required documents shall be filed with the Administrator. Filings shall be mailed to the offices of the Oklahoma Department of Securities, 120 North Robinson, Suite 860, Oklahoma City, Oklahoma 73102; submitted by facsimile at (405) 280-7742; or submitted by any other method that will assure delivery on or before the required date and time. All time deadlines in this order refer to times in the Central Time Zone.

3. Copies of all pleadings and exhibits and/or other required documents filed with the Administrator shall be served to the parties by mail at the following addresses or by facsimile or personal delivery:

4. No further discovery shall be allowed.

5. The parties shall file a Preliminary Witness List and a Preliminary Exhibit List, on or before 5:00 p.m. on January 23, 2006.

6. The parties shall file a Final Witness List and a Final Exhibit List, along with copies of all exhibits, on or before 5:00 p.m. on February 9, 2006. **Failure to comply with this paragraph will result in the exclusion of witnesses/exhibits at trial, subject to the provisions of 660:2-9-3(d) of the Rules.**

7. The parties are ordered to file and to provide each other and the Administrator, or his designee, a statement of the legal contentions that are to be presented at hearing on or before 5:00 p.m. on February 9, 2006.

8. A pre-hearing conference shall be conducted on February 16, 2006, at 9:30 a.m.

9. The final hearing in this proceeding shall commence at 10:00 a.m. on February 22, 2006, in the offices of the Oklahoma Department of Securities, First National Center, Suite 860, 120 North Robinson, Oklahoma City, Oklahoma.


10. Oral argument shall not be heard on pre-hearing motions. Argument will be submitted to the Administrator, or his designee, in writing and shall be disposed of by written order.

11. Failure to comply with the terms of this Order will result in sanctions including, but not limited to, default judgment against the Respondents.

IT IS FURTHER ORDERED that no date set by this Order can be changed except for good cause and upon written order of the Administrator, or his designee, prior to such scheduled date.


