

ORDER SETTING HEARING

WHEREAS, on December 21, 2001, a Recommendation to Revoke Registration (Recommendation) was submitted to the Administrator of the Oklahoma Department of Securities ("Department"). The Recommendation contains proposed Findings of Fact, Authorities and Conclusions of Law.

WHEREAS, on December 21, 2001, a copy of the Notice of Opportunity for Hearing (Notice) with the Recommendation attached was mailed by certified mail, return receipt requested, delivery restricted to addressee, to the last known addresses of Kimberly Securities, Inc. (Kimberly), Kimberly Jean Misaraca (Misaraca), John Patrick Donovan II (Donovan), and Philip Joseph Hourican (Hourican), in compliance with Section 413 of the Act.

WHEREAS, a written request for hearing on the Recommendation was received by the Department on January 11, 2002, on behalf of Kimberly, Misaraca, Donovan and Hourican.

WHEREAS, the Administrator finds that the request for hearing on the Recommendation was timely received.

IT IS HEREBY ORDERED that pursuant to 660:2-9-3 of the Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities, a hearing shall commence at 10:00 a.m. on March 5, 2002, in the offices of the Oklahoma Department of Securities, First National Center, Suite 860, 120 North Robinson, Oklahoma City, Oklahoma, to afford Kimberly, Misaraca, Donovan, and Hourican the opportunity to present evidence and argument as to whether or not a final order should be issued based on the Recommendation.


