

SCHEDULING ORDER

On November 23, 2005, the Administrator (Administrator) of the Oklahoma Department of Securities (Department) issued a Notice of Opportunity for Hearing (Notice) in the above styled and numbered cause. Notice with the attached Enforcement Division Recommendation (Recommendation) was served on Respondents on November 28, 2005. A response was received by the Department on December 12, 2005, on behalf of Marketing Solutions L.L.C. and J.J. Johnson. In their response, Respondents denied the first sentence contained in paragraph five (5) of the Recommendation. Respondents failed to deny the allegations contained in paragraphs one (1) through four (4), the second sentence in paragraph five (5), and paragraphs six (6) through eight (8) of the Recommendation. Respondents also claimed an exemption from registration under the Oklahoma Business Opportunity Sales Act.

On December 9, 2005, counsel for the Department's Enforcement Division telephoned Respondents to discuss a scheduling order. Respondents have failed to return the voice message asking them to call to discuss said order.

This Scheduling Order is issued pursuant to 660:2-9-3 of the Rules of the Oklahoma Securities Commission and the Administrator of the Oklahoma Department of Securities (Rules).

IT IS HEREBY ORDERED that:

1. Pursuant to Rule 660:2-9-2(a) of the Rules, the Findings of Fact contained in paragraphs one (1) through four (4), the second sentence contained in paragraph five (5), and paragraphs six (6) through (8) of the Recommendation are deemed to be admitted based on Respondents' failure to deny said allegations. The Finding of Fact contained in the first sentence of paragraph five (5) and the Conclusions of Law contained in the Recommendation are at issue.

2. The original of all pleadings and exhibits and/or other required documents shall be filed with the Administrator. Filings shall be mailed to the offices of the Oklahoma Department of Securities, 120 North Robinson, Suite 860, Oklahoma City, Oklahoma 73102; submitted by facsimile at 405.280.7742; or submitted by any other method that will assure delivery on or before the required date and time. All time deadlines in this order refer to times in the Central Time Zone.

3. Copies of all pleadings and exhibits and/or other required documents filed with the Administrator shall be served to the parties by mail at the following addresses or by facsimile or personal delivery:

4. No further discovery shall be allowed.

5. The parties shall file a Preliminary Witness List and a Preliminary Exhibit List, on or before 5:00 p.m. on February 27, 2006.

6. The parties shall file a Final Witness List and a Final Exhibit List, along with copies of all exhibits, on or before 5:00 p.m. on March 8, 2006. **Failure to comply with this paragraph will result in the exclusion of witnesses/exhibits at hearing pursuant to the provisions of 660:2-9-3(c) of the Rules.**

7. The parties are ordered to provide each other and the Administrator, or his designee, a statement of the legal contentions that are to be presented at hearing, on or before 5:00 p.m. on March 8, 2006.

8. A pre-hearing conference shall be conducted on March 9, 2006, at 9:30 a.m. by telephone. Respondents shall participate in the pre-hearing conference call by dialing 405.280.7738.

9. If the parties desire to file a hearing brief, the brief must be filed on or before 5:00 p.m. on March 16, 2006.


