**ORDER CONSTRUING CONSERVATORSHIP ORDER ON  
 APPLICATION OF CONSERVATOR FOR GUIDANCE**

NOW on this 16<sup>th</sup> day of May, 2003, the application of Conservator, Tom Moran, for instructions regarding the interpretation of the Order Appointing Conservator and Transferring Assets dated February 6, 2002 (the "Conservatorship Order"), came on for consideration before the undersigned judge. The Court having reviewed the application, being advised that Plaintiff believes that it would be outside the scope of the Conservatorship for the Conservator to pursue an action on behalf of investors against Defendant, Accelerated Benefits Corporation ("ABC"), its officers, directors or agents, for losses sustained by the investors as a result of their investment with ABC, and no objection being filed by Defendants, finds that the Conservator has no duty, under the Conservatorship Order, to pursue any action against ABC, its officers, directors or agents, on behalf of the ABC investors for losses sustained as a result of their investment with ABC.


IT IS THEREFORE ORDERED ADJUDGED AND DECREED that the Conservator has no duty, under the Order Appointing Conservator and Transferring Assets dated February 6, 2002, to pursue any action against ABC, its officers, directors or agents, on behalf of the ABC investors for


