**ORDER**

On May 1, 2012, the Oklahoma Department of Securities (Department) issued Subpoenas Duces Tecum (Subpoenas) to Bank of America and to Priority Bank for the production of financial records relating to the bank accounts of Respondents. Respondents were provided notice of the Subpoenas pursuant to the requirements of the Oklahoma Financial Privacy Act, Okla. Stat. tit. 6, §§ 2201 *et. seq.* (2011).

On May 21, 2012, Mickey K. Leslie, attorney for Respondents Vernon Ray Twyman, Jr., Jamie Twyman, Jeffrey John Long, Wycliffe USA Ltd., Advanced Recovery Systems, Inc., Asian Precious Metals, Inc., and Ventures 7000, LLC, faxed a letter to the Deputy Administrator of the Department requesting that the Subpoenas be quashed.

The Enforcement Division of the Department filed a response to the motion to quash on May 23, 2012.

The records requested by the Subpoenas are relevant to the purpose of the Department's investigation into possible violations of the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011) by Respondents.


The release of the financial records by Bank of America and Priority Bank will not cause an unreasonable burden or hardship on Respondents.
