ORDER FOR TURNOVER

This matter came on for hearing this 31st day of October, 2003, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, on the Application for Status Conference and Order for Turnover filed by the Plaintiff Oklahoma Department of Securities. Present for the Plaintiff was its counsel, Patricia A. Labarthe. Present for the Defendant was its counsel, Dino Viera. The Court, having considered the following, finds that an order for turnover is necessary and finds as follows:

1. Counsel for ABC requested that D.R. Payne & Associates ("D.R. Payne") conduct an audit of the records of ABC for the purpose of a) identifying all assets subject to the *Order Appointing Conservator and Transferring Assets* dated February 6, 2002 ("Conservatorship Order"); b) determining whether such assets were transferred as required by the Conservatorship Order; c) determining the amount of funds collected from ABC investors matched with any viatical policy subject to the Conservatorship

Order and the disposition of such funds; and d) determining the amount and source of any funds advanced by ABC for the payment of premiums.

2. Counsel for ABC represented to the Court that ABC and Keith LaMonda ("LaMonda") would pay for the total cost of the audit.

3. In March of 2003, this Court ordered the audit under the terms of the Engagement Letter dated March 5, 2003.

4. ABC and LaMonda have failed to sign a letter authorizing ABC's bank(s) to release directly to D.R Payne specific records necessary for completion of the audit ("Letter of Authorization").

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that ABC and LaMonda sign and return the Letter of Authorization to D.R. Payne by 5:00 p.m. on Tuesday, November 4, 2003.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that LaMonda pay attorneys fees incurred in making this application to the Plaintiff in the sum of \$ _____ on or before November 5, 2003.


