ORDER GRANTING MOTION TO WITHDRAW

This matter came on for consideration upon the motion filed by Conner L. Helms, Gary R. Underwood, and Rebecca A. Farris of the law firm Helms & Underwood to withdraw as counsel for ABC Investors John C. Hinkle and Wanda B. Hinkle (collectively referred to herein as the "Hinkles"). The Court, having reviewed the motion and being advised that there is no objection by the Hinkles or counsel for any other party, finds that said motion should be granted.

IT IS THEREFORE ORDERED that Conner L. Helms, Gary R. Underwood, and Rebecca A. Farris of the law firm Helms & Underwood are permitted to withdraw as counsel for the Hinkles.

IT IS FURTHER ORDERED that, within thirty (30) days of the date of this Order, the Hinkles must cause an entry of appearance to be filed either by substitute counsel or by themselves *pro se*. If no entry of appearance is filed within thirty (30) days from the date of this Order, then the Hinkles are deemed to represent themselves *pro se*. Failure of the Hinkles to prosecute or defend the case may result in dismissal of the case without prejudice or the entry of a default judgment against them.

IT IS FURTHER ORDERED that, in accordance with 12 O.S. § 2005(B), service of all

documents filed in this cause may be accomplished by mailing a copy of such documents to the Hinkles at their last known addresses:

Wanda B. Hinkle, c/o John C. Hinkle, 3924 Tumbril Lane, Plano, Texas 75023.


IT IS FURTHER ORDERED that service of this order shall be made upon the Hinkles by certified mail.


