ORDER GRANTING
MOTION OF RECEIVER, STEPHEN J. MORIARTY FOR
AUTHORITY TO SELL REAL PROPERTY

Comes on for consideration on the Motion of Receiver, Stephen J. Moriarty for authority to sell certain real property located in Lincoln County owned by the Defendants; Receiver appearing *pro se*; and it appearing to the Court that good cause exists for the granting of said Motion,

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Receiver is authorized to conduct a public auction, to be held on July 23, 2005, of all real property owned by Defendants located in Lincoln County, Oklahoma, on reasonable notice and

advertisement, as determined by Receiver after consultation with appropriate professionals.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Receiver is authorized to employ Vernon Markwell and Markwell Real Estate (collectively referred to as "Markwell") to assist him in the auction of the Real Property on such terms and conditions as are reasonable.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Receiver shall file a written report with the Court within five (5) days of the closing of any sale contemplated hereunder.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that any proceeds of any sale authorized by this Order shall be placed in a segregated bank account awaiting further Order of this Court.
