

**ORDER REINSTATING REGISTRATIONS**

**Findings of Fact**

1. On May 25, 2007, the Administrator ("Administrator") of the Oklahoma Department of Securities ("Department") issued an order summarily suspending the investment adviser registration of Legacy Wealth Management, LLC ("Legacy") and the investment adviser representative registration of Jasper E. Bidy IV ("Bidy") ("Summary Order"), pursuant to Section 1-411 of the Oklahoma Uniform Securities Act of 2004 ("Act"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003), and 660:11-7-45 of the Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities (as adopted July 1, 2004) ("Rules").

2. The Summary Order was based on Respondents' failure to provide access to certain books and records of Legacy to the Examinations Division of the Department ("Examinations Division") thereby impeding a representative of the Administrator from conducting an inspection under Section 1-410 of the Act.

3. On June 28, 2007, Respondents provided the Examinations Division with access to the requested books and records of Legacy for purposes of an inspection under Section 1-410 of the Act.

To the extent any of these Findings of Fact are more properly characterized as Conclusions of Law, they should be so considered.

**Conclusions of Law**

1. The grounds by which Respondents' registrations were summarily suspended are no longer applicable.

2. The Administrator is authorized to reinstate the registrations of Respondents.


To the extent any of these Conclusions of Law are more properly characterized as Findings of Fact, they should be so considered.


