

**ORDER SETTING HEARING AND NOTICE OF HEARING**

On August 23, 2007, at the hearing on the *Second Summary Order Suspending Registrations* ("Second Summary Order"), Respondents moved that the hearing on the Second Summary Order be continued to an indefinite date to afford Respondents the opportunity to seek relief in the District Court from the denial of the motion. The motion was granted, further hearing on the Second Summary Order was continued, and the Second Summary Order was extended. On August 20, 2007, the District Court denied the Respondents' request for an injunction to prevent the Administrator from hearing the matter.

Counsel for the Department represent that the parties have agreed to consolidate the hearing on the Second Summary Order with the hearing on the Enforcement Division's recommendation to revoke the registrations of Respondents. Department's counsel further represents that all parties have agreed to set such hearing for September 13, 2007, at 10:00 a.m.

**IT IS HEREBY ORDERED** that pursuant to Section 1-411 of the Oklahoma Uniform Securities Act of 2004, Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2004), a hearing shall commence at **10:00 a.m.** on **September 13, 2007**, at the offices of the Oklahoma Department of Securities, First National Center, Suite 860, 120 North Robinson Avenue, Oklahoma City, Oklahoma, to afford Respondents an opportunity for hearing on the issue of whether an order revoking their registrations should be issued. The Second Summary Order shall be extended until further order of the Administrator.


