ORDER SETTING SCHEDULING CONFERENCE

WHEREAS, on March 26, 2013, the Enforcement Division submitted to the Administrator of the Oklahoma Department of Securities (Administrator) its recommendation (Recommendation) for sanctioning Rodney Larry Watkins, Jr. (Watkins), Southeast Investments, N.C. Inc. (Southeast), and Frank H. Black (Black) (collectively, "Respondents"), pursuant to Section 1-411 of the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011), for alleged violations of Sections 1-402 and 1-505 of the Act and 660:11-5-42 of the Rules of the Oklahoma Securities Commission and the Administrator of the Oklahoma Department of Securities (Rules), Okla. Admin. Code §§ 660:1-1-1 through 660:25-7-1.

WHEREAS, on March 29, 2013, the Administrator issued the Respondents a Notice of Opportunity for Hearing (Notice) and a Notice of Service on the Administrator and Affidavit of Compliance (Affidavit).

WHEREAS, on March 29, 2013, a copy of the Notice with a copy of the Recommendation attached was sent by certified mail, return receipt requested, delivery restricted to addressee, to the last known addresses of Respondents, in compliance with Section 1-611 of the Act.

WHEREAS, on April 15, 2013, Respondents filed their answers and requested a hearing.

WHEREAS, on May 9, 2013, pursuant to Section 1-411 of the Act and 660:2-9-2 of the Rules, a hearing was ordered to commence at 10:00 a.m. on October 22, 2013.

WHEREAS, on May 10, 2013, Respondents requested the hearing date be stricken and rescheduled.

WHEREAS, after the parties failed to agree on an alternative hearing date, an order striking the October 22, 2013 hearing was entered.



- 1) set the date and time of the hearing, and
- 2) establish a scheduling order pursuant to 660:2-9-3(a) of the Rules.

Failure to participate in this scheduling conference may result in sanctions as authorized by 660:2-9-3(f) of the Rules, including the entry of a default judgment, without further notice to the parties.


