ORDER TERMINATING REGISTRATION

The Administrator of the Oklahoma Department of Securities ("**Administrator**") issues this Order pursuant to Section 1-408(E) of the Oklahoma Uniform Securities Act of 2004 ("**Act**"), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (2011 and Supp. 2016).

Findings of Fact

1. Wilbanks Securities, Inc. ("**Respondent**") is an Oklahoma corporation that has been registered under Oklahoma's securities laws as a broker-dealer at all times since July 2, 1996. The main office of Wilbanks Securities is located in Oklahoma City.
2. Respondent became a member of the Financial Industry Regulatory Authority ("**FINRA**") on August 7, 1996.
3. Effective October 6, 2017, Respondent's membership with FINRA was cancelled for failure to pay outstanding fees.
4. Respondent is no longer effecting transactions in securities for the account of others or for its own account.

To the extent any of these Findings of Fact are more properly characterized as Conclusions of Law, they should be so considered.

Authority

Section 1-408 of the Act provides, in pertinent part:

- E. If the Administrator determines that a registrant or applicant for registration is no longer in existence or has ceased to act as a broker-dealer, agent, investment adviser, or investment adviser representative, or is the subject of an adjudication of incapacity or is subject to the control of a committee, conservator, or guardian, or cannot reasonably be located, a

rule adopted or order issued under this act may require the registration be canceled or terminated or the application denied. The Administrator may reinstate a canceled or terminated registration, with or without a hearing, and may make the registration retroactive.

Conclusions of Law

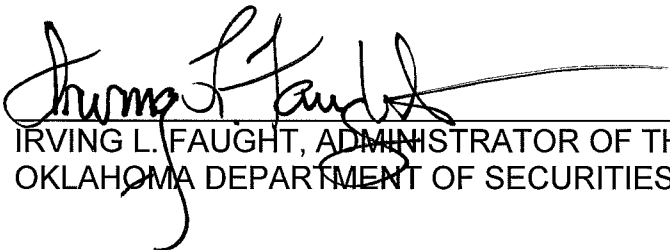
1. Respondent has ceased to act as a broker-dealer.
2. The Administrator is authorized under Section 1-408(E) of the Act to cancel Respondent's registration under the Act as a broker-dealer.
3. It is in the public interest for the Administrator to cancel Respondent's registration under the Act as a broker-dealer.

To the extent any of these Conclusions of Law are more properly characterized as Findings of Fact, they should be so considered.

WHEREFORE, IT IS HEREBY ORDERED that Respondent's registration under the Act as a broker-dealer is terminated.
