
**ORDER TO MODIFY ORDER FREEZING ASSETS**


IT IS ORDERED that:



2. Except to the extent specifically provided in this Order, all of the provisions of the Court's order dated October 14, 2004; the Temporary Order relating to Richard L. Schubert


dated December 10, 2004; and the Order Amending Authority of Receiver entered on December 10, 2004, shall continue in full force and effect until further order of the Court.

**JOINT MOTION TO MODIFY ORDER FREEZING ASSETS**

Plaintiff, the Oklahoma Department of Securities *ex rel.* Irving L. Faught, Administrator (the "Department"), Douglas L. Jackson, Receiver ("Receiver"), and Richard L. Schubert, move the Court to modify the order freezing assets issued by this Court on October 14, 2004, by unfreezing two bank accounts: the Richard Schubert Farm account at BancFirst in Kingfisher, Oklahoma, and the Schubert Implement account at First National Bank in Miami, Oklahoma. In support of this Joint Motion, the moving parties show the Court as follows:

1. On October 14, 2004, the Department filed its Application for Temporary Restraining Order, Order Freezing Assets, Order Appointing Receiver, and Order for Accounting in this matter.

2. On October 14, 2004, the Court issued a Temporary Restraining Order, Order Freezing Assets, Order Appointing Receiver, and Order for Accounting.


3. On December 10, 2004, the Temporary Restraining Order, Order Freezing Assets, Order Appointing Receiver, and Order for Accounting was modified by agreement of the parties, thereby giving Richard L. Schubert immediate possession of certain real and personal property during the pendency of the case.

4. On April 4, 2005, the Department dismissed Richard Schubert as a Defendant in this matter.




