


APPLICATION FOR EXTENSION OF TIME TO RESPOND

Plaintiff, Oklahoma Department of Securities *ex rel.* Irving L. Faught, Administrator, respectfully applies to the Court for an order extending the time to respond to the Motion for Leave to Sue Conservator and Supporting Memorandum filed by Texas Life Insurance Company ("Texas Life Motion"). In support of this application, the Plaintiff states as follows:

1. The Texas Life Motion was filed on July 18, 2006, seeking leave for Texas Life Insurance Company to bring an action against HTM Conservator, LLC in another jurisdiction.
2. Plaintiff's response is currently due on August 7, 2006.
3. The hearing on the Texas Life Motion was originally set for August 18, 2006, and has been continued to September 1, 2006, at the request of counsel for Conservator, H. Thomas Moran.
4. Additional information not yet received by Plaintiff may be relevant to Plaintiff's position and that information is expected to be obtained in the next week.
5. Counsel for Texas Life in Oklahoma and Georgia have no objection to this extension of time.
6. Plaintiff has not previously moved for an extension of time.


