**ORDER VACATING TEMPORARY RETRAINING ORDER AND WITHDRAWING
APPLICATION FOR TEMPORARY INJUNCTION
WITH RESPECT TO JAMES S. STANLEY**

This matter is before the Court on the Joint Motion of the Plaintiff, the Oklahoma Department of Securities ex rel. Irving L. Faught, Administrator (the "Department") and Defendant, James S. Stanley, to vacate and dissolve the Temporary Restraining Order, Order Freezing Assets and Order for Accounting obtained by Plaintiff on August 2, 2004, and to withdraw the Application for Temporary Injunction filed August 2, 2004, with respect to James S. Stanley.

IT IS ORDERED that:

1. The Temporary Restraining Order, Order Freezing Assets and Order for Accounting with respect to James S. Stanley is vacated and dissolved.
2. The Application for Temporary Injunction with respect to James S. Stanley is withdrawn.

3. James S. Stanley is ordered to post a bond herein in the amount of \$24,140 in the form of a stand-by letter of credit or surety bond by close of business Tuesday, August 10, 2004.

4. All of the provisions of the Court's Order dated August 2, 2004, shall continue in full force and effect, unamended and unmodified, except to the extent specifically provided in this Order, until further order of the Court.


