ORDER -- CITATION FOR CONTEMPT

On this 3rd day of April, 1998, the plaintiff's Application for Contempt Citation against defendant Randall D. Jeffers ("Jeffers") comes on for hearing before this Court. Plaintiff appears by and through its attorney, Mark S. Edmondson, and Henry A. Meyer, III, enters his appearance as attorney in this matter for Jeffers and appears at this hearing on his behalf.

Plaintiff announced ready to present evidence and show cause why a citation for contempt should be issued and Jeffers should be required to appear and show cause why he should not be punished for indirect contempt of this Court's Order. Jeffers waived the presentation of such evidence and requested that this matter be set for trial before this Court.


It is therefore ORDERED that sufficient cause is found to require Jeffers to present himself before this Court on the 8th day of September, 1998, at 9:00 o'clock A.M. prepared to respond to evidence by the plaintiff and show cause why he should not be punished


for indirect contempt of this Court's Order as set forth in the Application for Contempt filed by the plaintiff in this matter.

Evidence having been offered which alleges Jeffers willfully failed to comply with the Order of the Court made and entered on the 16th day of January, 1998, wherein this Court ordered Jeffers restrained from offering any unregistered business opportunity and ordered Jeffers to disclose all actions filed against Jeffers and others, and whereas Jeffers has been notified in writing and shall have a reasonable time for preparation of defense between such notification and the trial date set as required by Okla. Stat. tit 21, § 567 (Supp. 1997), it is therefore ORDERED you be cited for indirect criminal contempt and YOU ARE THEREFORE COMMANDED TO APPEAR before Judge Blevins of this Court on the 8th day of September, 1998, at 9:00 o'clock A.M. and show cause why you should not be punished for criminal contempt of court.
