JUDGMENT

This matter came on for trial this 6th day of March, 2000, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, upon the petition of the Plaintiff for a permanent injunction against Randall D. Jeffers pursuant to Section 814.A.2. of the Oklahoma Business Opportunity Sales Act ("Act"), Okla. Stat. tit. 71, § 801-827, (1991 & Supp. 1999). Plaintiff appears by and through its attorney of record, Mark S. Edmondson. Defendant Randall D. Jeffers did not appear.

It appears to this Court from the facts alleged in Plaintiff's verified petition for permanent injunction that Plaintiff is entitled to the relief for which it has prayed against Randall D. Jeffers.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that a permanent injunction be and is hereby entered, forever enjoining, restraining and prohibiting Defendant Randall D. Jeffers, his employees, agents, and other individuals in active concert or participation with him, from, directly or indirectly, issuing, offering or selling any business opportunity in and/or from the state of Oklahoma.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a permanent injunction be and is hereby entered, enjoining, restraining and prohibiting Defendant Randall D. Jeffers from making a public appearance or presentation, through any medium, in any form, in the state of Oklahoma on behalf of any individual, corporation, trust, partnership, incorporated or unincorporated association or any other entity that offers or sells a business opportunity or in connection with any business opportunity.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a permanent injunction be and is hereby entered, enjoining, restraining and prohibiting Defendant Randall D. Jeffers from making a public endorsement, through any medium, in any form, in the state of Oklahoma, and/or to any person in the state of Oklahoma from outside the state of Oklahoma, of any individual, corporation, trust, partnership, incorporated or unincorporated association or any other entity that offers or sells a business opportunity or in connection with any business opportunity.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a permanent injunction be and is hereby entered, enjoining, restraining and prohibiting Defendant Randall D. Jeffers from directly or indirectly serving as an officer, director, or control person for any individual, corporation, trust, partnership, incorporated or unincorporated association or any other entity that offers or sells a business opportunity in and/or from the state of Oklahoma.

IT IS SO ORDERED.
