SCHEDULING ORDER

THIS ORDER is entered this 17 day of June, 1999, Counsel have discussed their respective need for adequate discovery time, complexity of legal issues to be addressed, and their caseload in arriving at this agreed Scheduling Order.

IT IS ORDERED that the following must be completed within the time fixed:

1. JOINDER OF ADDITIONAL PARTIES and AMENDMENT TO THE PLEADINGS must be filed no later than 30 days before pretrial.
2. DISCOVERY: Completed (answered) by pretrial. FINAL LIST OF WITNESSES AND EXHIBITS: Exchanged 30 days before pretrial.
3. ALL DISPOSITIVE MOTIONS: Filed within time to be heard at pretrial. All legal questions and issues, including Motions in Limine must be provided to the Judge on the day of trial. Failure to do so waives the legal question or issue. All other motions must be filed by pretrial.
4. MEDIATION: Completed by pretrial.
5. PRETRIAL CONFERENCE DATE & TIME: July 14, 1999 @ 1:30 pm
6. JURY NON-JURY Party requesting jury trial shall immediately pay court costs pursuant to 28 O.S. § 152.1.
7. TYPE OF CASE: Wreck ESTIMATED TIME OF TRIAL: 1 day
8. TRIAL DATE: TO BE SET AT PRETRIAL.
9. REQUESTED JURY INSTRUCTIONS: a complete set in usable form, including verdict forms, must be brought to the first day of trial, along with a disk containing the required instructions.
10. PROPOSED FINDINGS OF FACT AND CONCLUSIONS OF LAW: (Non-jury) Filed by trial.
11. TRIAL BRIEF: Only required for undecided legal questions.
12. PRETRIAL CONFERENCE ORDER: Agreed to and delivered to Judge at Pretrial. DO NOT file the unsigned original Pretrial Order with the Court Clerk.
13. **IT IS FURTHER ORDERED**: All exhibits must be exchanged and marked 10 days before trial. If exhibits are not exchanged 10 days before trial, they will not be allowed at trial. This schedule may be modified only upon written motion and for good cause shown and by Order of this court prior to the dates scheduled. Failure to comply with this Order may result in sanctions pursuant to Rule 5 (J) of the Rules of the District Courts. **Failure to appear** at Pretrial Conference will result in the entry of a default judgment or dismissal order as deemed appropriate by this Court, without further notice to the parties.
