SECOND AMENDMENT TO TEMPORARY RESTRAINING ORDER

Pursuant to the agreement of the plaintiff Oklahoma Department of Securities *el rel* Irving L. Faught and defendants Eddie Elkins and Elkins & Associates, Inc., it is hereby ordered that the Temporary Restraining Order, Order Freezing Assets and Order for Accounting entered herein on August 2, 2004 ("TRO"), as amended by order of this Court on August 6, 2004, is hereby modified and amended as follows:

All restraints by this Court as to the utilization of funds held in accounts maintained by defendants Eddie Elkins and Elkins & Associates, Inc at Peoples National Bank, Yukon National Bank, and Arvest Bank are hereby vacated, terminated, and dissolved.

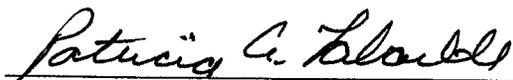
Defendants Eddie Elkins and Elkins & Associates, Inc are hereby temporarily enjoined from making or permitting any transfer of money or property held by them that is not in the ordinary course of business of said defendants; provided, however, during the pendency of this order, said defendants may make transfers of money or property outside the ordinary course of business upon receipt of written authorization for any such transfer from the Oklahoma Department of Securities.

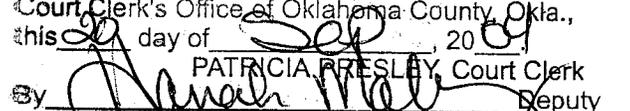
