

TRUSTEE'S APPLICATION TO PAY SECURED CREDITOR

JANICE D. LOYD, Trustee, respectfully applies to the Court for an Order authorizing her to pay over to the secured creditor, Information Leasing Corporation, the amount of \$12,058.59 representing payment of its secured lien out of sale proceeds to be received from the sale of estate assets located in Sallisaw, Oklahoma. In support of said application, the trustee would advise the Court that she filed her Motion for Order authorizing her to sell personal property located in Sallisaw, Oklahoma, to Steve D. Blount on the 28<sup>th</sup> day of October, 2003. On November 20, 2003, the Court entered an Order authorizing the Trustee to proceed with the sale. That Information Leasing Corporation holds a secured lien on a Q300 Lantech semi-automatic wrapper machine which will attach to the sale proceeds to be received by the Bankruptcy Estate. The trustee has determined that the amount due and owing to Information Leasing Corporation is \$12,058.59.

WHEREFORE, the Trustee, Janice D. Loyd, respectfully prays the Court issue an Order authorizing her to pay over to Information Leasing Corporation the sum of \$12,058.59 in payment of its secured lien on the Q300 Lantech semi-automatic wrapper machine located in Sallisaw, Oklahoma, being specifically described in Trustee's Motion, out of the sale proceeds received by the bankruptcy estate, and for such other and further relief as is just and equitable.


