**ORDER AUTHORIZING SEVENTH INTERIM APPLICATION BY ERIC L.

NECESSARY EXPENSES FOR THE PERIOD OF

NOW on this 16th day of June 2025, the duly appointed Receiver, Eric L. Johnson's (the "Receiver") *Seventh Interim Application for Allowance of Compensation for Services Rendered and Reimbursement of Actual and Necessary Expenses for the Period of October 1, 2024 through December 31, 2024* (the "Application") comes before the Court, and after appropriate notice and opportunity for a hearing, with no objections filed by the objection deadline; and for good cause shown:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

1. The Application is granted.
2. The Seventh Interim Fees are allowed in the following amounts: (a) \$56,752.50 in fees for the Receiver; (b) \$212,388.97 in legal fees and expenses for Spencer Fane; and (c) \$3,714.00 in expenses for BRG.

3. The payments already made or authorized to be made pursuant to the monthly compensation procedures are hereby ratified and/or further authorized to be paid.

4. The Receiver and his professionals are authorized to pay and/or apply the 20% holdback of the Seventh Interim Fees in the total amount of \$29,314.50 that have been incurred but not yet paid (the "Holdback Amounts").




