**ORDER GRANTING EMERGENCY MOTION OF DEFENDANT
RICHARD DALE DEAN TO RENEW, EXTEND, AND MODIFY THE COURT'S
MARCH 14, 2023, ORDER AND TO AMEND HIS PROJECTED 2023 CASE BUDGET**

Before the Court is the Emergency Motion to Renew, Extend, and Modify the Court's March 14, 2023, Order and to Amend His Projected 2023 Case Budget ("Motion") filed by Defendant Richard Dale Dean. The Court, after considering the Motion and for good cause shown, finds that the Motion should be granted.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendant's Motion is **GRANTED**.


The Court directs that the March 14, 2023, Order on Defendant Richard Dale Dean and DDI Advisory Group, LLC's Emergency Motions for Partial Lifting of Asset Freeze to Permit Payment of Living Expenses and for Partial Lifting of Asset Freeze to Permit Payment of Legal Fees ("March Freeze Order") that provides for a partial life of an asset freeze and procedures for payment of legal fees be renewed and extended with a new expiration date of January 11, 2024, at 11:59 p.m. (CST) unless further extended by the Court.

The Court further directs that the March Freeze Order be modified to include payment of legal fees to the Dean Defendants' counsel's new firm of Steptoe & Johnson PLLC subject to the same procedures outlined in the March Freeze Order, beginning on May 1, 2023, and forward.




