**ORDER ON DEFENDANT RICHARD DALE DEAN AND DDIA’S MOTION TO  
QUASH SUBPOENA DUCES TECUM TO GABLEGOTWALS**

The above-styled case came before the Court on Defendant Dean and DDI Advisory Group’s (“DDIA”) Motion to Quash the Receiver’s Subpoena and Subpoena Duces Tecum issued to GableGotwals on December 22, 2023. The Court, after considering Defendant Dean and DDIA’s Motion to Quash, the Receiver’s objections to the Motion to Quash, and arguments of counsel, and for good cause shown, finds that the Motion to Quash should be denied in part and granted in part as follows:

1. The Court denies Defendant Dean and DDIA’s Motion to Quash as it relates to the business entities and business Receivership Defendants, including, Premier Global Corporation, f/k/u Premier Construction Services, Inc., d/b/a Premier Construction Billing, Premier Factoring, LLC, PF-2, LLC, PF-3, LLC., PF-4, LLC, PF-5, LLC, PF-6, LLC, PF-7, LLC, Premier Factoring Group, LLC, and DDIA Group (“Business Entities”). Accordingly, any documents relating to these Business Entities shall be produced by GableGotwals.
2. The Court finds that there are two categories of documents at issue:
  - a. The 44,000 documents previously produced by GableGotwals to DDIA and Dean’s attorneys; and
  - b. Communications between GableGotwals and Richard Dean.

3. As it relates to the first category of documents, GableGotwals is ordered to produce the 44,000 documents previously produced to DDIA and Dean's attorneys by GableGotwals as well as any of the documents requested in the Subpoena that relate to the Business Entities, within ten (10) days of the hearing on the Receiver's Motion to Settle Journal Entry or by June 14, 2024. Richard Dean's attorneys shall produce a privilege log to the Receiver and ODS for any documents they believe are privileged, and there will be no waiver of the attorney-client privilege for any document identified on the privilege log but produced by GableGotwals within this category of documents.
4. As it relates to the second category of documents of communications between GableGotwals and Richard Dean, GableGotwals is ordered to produce these communications to Richard Dean's attorneys within twenty (20) days. Within ten (10) days of receipt of this second category of documents, Richard Dean is ordered to turn over the documents to the Receiver and ODS or provide a privilege log to the Receiver and ODS.


