

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Defendant Kalidy, individually and as an owner, officer, director, member, manager, partner, or employee of any business entity, be and hereby is permanently enjoined from transacting business in and/or from the state of Oklahoma as an issuer, issuer agent, broker-dealer, broker-dealer agent, investment adviser, and/or investment adviser representative; from otherwise offering and/or selling securities in and/or from the state of Oklahoma (collectively, "Securities Transactions"); and from otherwise violating the Act; provided however, the foregoing shall not prohibit Defendant Kalidy from conducting business (other than Securities Transactions) in accordance with the laws of the state of Oklahoma.

IT IS FURTHER ORDERED that Defendant Kalidy be and hereby is enjoined from tampering with, mutilating, altering, erasing, concealing, removing, destroying or otherwise disposing of any and all books, records, documents, files, correspondence, computer disks, tapes or other data recordings of any type, pertaining to or referring to Defendant Kalidy, and/or Trillium Medical Spa LLC, Trillium Medical Spa Plus LLC, Trillium Supreme Wash LLC, and Trillium Supreme Wash Plus LLC, until further order of this Court.

IT IS FURTHER ORDERED that the Order Freezing Assets contained as part of the Temporary Restraining Order entered on June 10, 2024, without notice, is hereby lifted.

IT IS FURTHER ORDERED that Defendant Kalidy, upon reasonable notice and during regular business hours, allow representatives of the Oklahoma Department of Securities access to any and all documents in his possession relating to the alleged sales of securities as described Plaintiff's Application and the business of Trillium Medical Spa

LLC, Trillium Medical Spa Plus LLC, Trillium Supreme Wash LLC, and Trillium Supreme Wash Plus LLC, their subsidiaries, officers, directors, agent, servants, employees, assigns, and all persons acting on their behalf, under their direction and control, and/or in active concert or participation with them, including, but not limited to, books records, tapes, discs, accounting data, checks, correspondence, forms, advertisements, brochures, manuals, electronically stored data, bank records, customer and investor lists, customer and investor files, telephone records, ledgers, payroll records, to include such information stored in computer maintained form.

IT IS FURTHER ORDERED that Defendant Kalidy shall provide notice of this Order to each of his affiliates, successors, directors, officers, and each of their employees, salespersons, and representatives.

This Agreed Order memorializes the Court's ruling on Plaintiff's *Application for Temporary Restraining Order, Order Freezing Assets, and Order For Accounting Without Notice, and For Temporary Injunction* filed on June 10, 2024, as well as the parties' agreements represented to the Court regarding the matters addressed herein. This Agreed Order does not resolve the allegations and causes of action in Plaintiff's Petition or the Defendant's defenses thereto, which remain at issue, but memorializes the parties' agreement with respect to entry of a permanent injunction as set forth above.


