ORDER ALLOWING WITHDRAWAL

Upon consideration of the motion of Mark H. Bennett and Socorro Adams Dooley requesting an order of the Court allowing them to withdraw as counsel for the Defendant Rabih Kalidy. 
further directed to serve a copy of this Order on Rabih Kalidy, and on each of the other parties hereto, or their counsel.


