JUDGMENT ENFORCING
ADMINISTRATIVE ORDER COMPLIANCE

This action came before the Court on the motion of the Oklahoma Department of Securities *ex rel.* Melanie Hall, Administrator (the "Plaintiff"), for default judgment against Defendant Oxford Gold Group, Inc.

The Court, having reviewed the Plaintiff's *Application to Enforce Compliance with an Order to File Statement and Authority in Support* (the "Application"), summons, certificate of service and court file, finds that the Defendant has been validly served with the Application and summons; that the date by which the Defendant was required to appear and defend this action was September 11, 2024; that no appearance has been made by said Defendant; that no motion or pleading has been filed on its behalf; and that, pursuant to Dist. Ct. Rule 10, notice of taking default is not required.

The Court, being fully advised on the premises, and on consideration thereof, finds that the Defendant is in default and that Plaintiff is entitled to judgment

against the Defendant.


