JUDGMENT

This action came before the Court on the motion of the Oklahoma Department of Securities *ex rel.* Melanie Hall, Administrator (the "Plaintiff"), for default judgment against Defendant Resource Exploration & Production, Inc.

The Court, having reviewed the Plaintiff's *Application to Enforce Subpoena Compliance and Authority in Support* (the "Application"), summons, return of service and court file, finds that the Defendant has been validly served with the Application and summons; that the date by which the Defendant was required to appear and defend this action was January 6, 2025; that no appearance has been made by said Defendant; that no motion or pleading has been filed on its behalf; and that, pursuant to Dist. Ct. Rule 10, notice of taking default is not required.


The Court, being fully advised in the premises, and on consideration thereof, finds that the Defendant is in default and that Plaintiff is entitled to judgment against the Defendant.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, until this Court finds that the Defendant has complied with the Subpoena's requirements, the Defendant, and any entity the Defendant owns and/or controls, is enjoined from offering or selling securities or conducting any and all business or commercial activities in and/or from the State of Oklahoma.
