## **JUDGMENT**

This action came before the Court on the motion of the Oklahoma Department of Securities ex rel. Melanie Hall, Administrator (the "Plaintiff"), for default judgment against Defendant Resource Exploration & Production, Inc.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, until this Court finds that the Defendant has complied with the Subpoena's requirements, the Defendant, and any entity the Defendant owns and/or controls, is enjoined from offering or selling securities or conducting any and all business or commercial activities in and/or from the State of Oklahoma.


